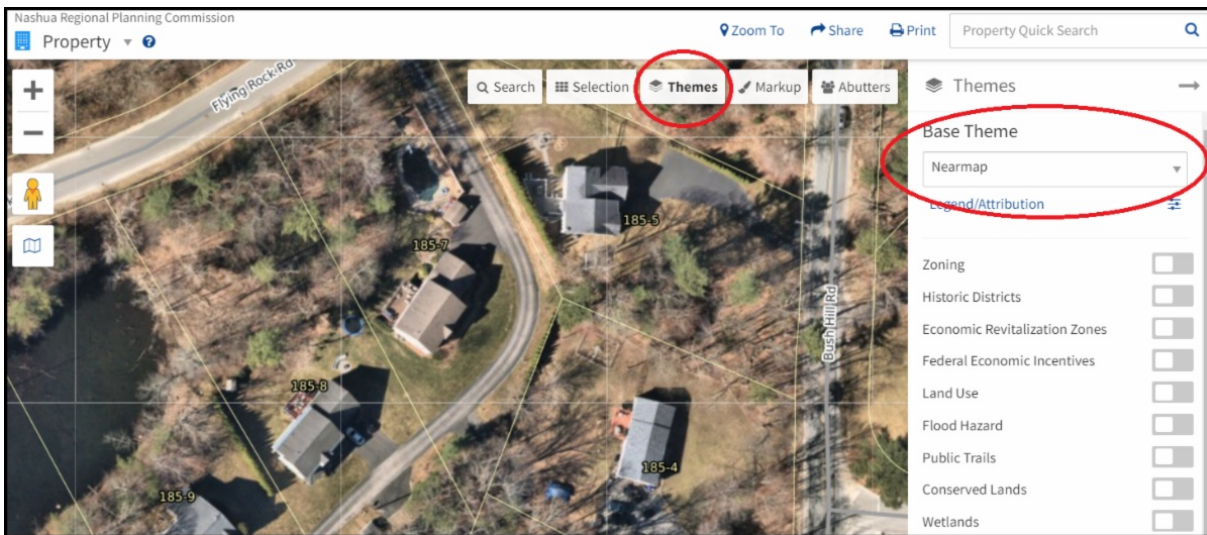

## MapGeo Enhancements



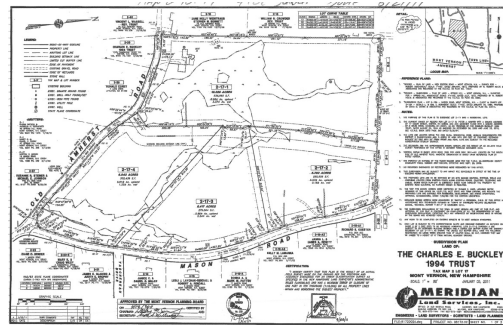
### Spring 2023 Aerial Imagery Now in MapGeo!

NRPC has subscribed to Nearmap, a commercial imagery service. Now, MapGeo users can access high resolution, leaf-off imagery from spring 2023 imagery! To check it out, [visit MapGeo](#) and toggle the Base Theme setting to Nearmap. Nearmap coverage of the NRPC region is nearly complete. In Spring 2024, Nearmap will expand coverage to include the remaining western areas.

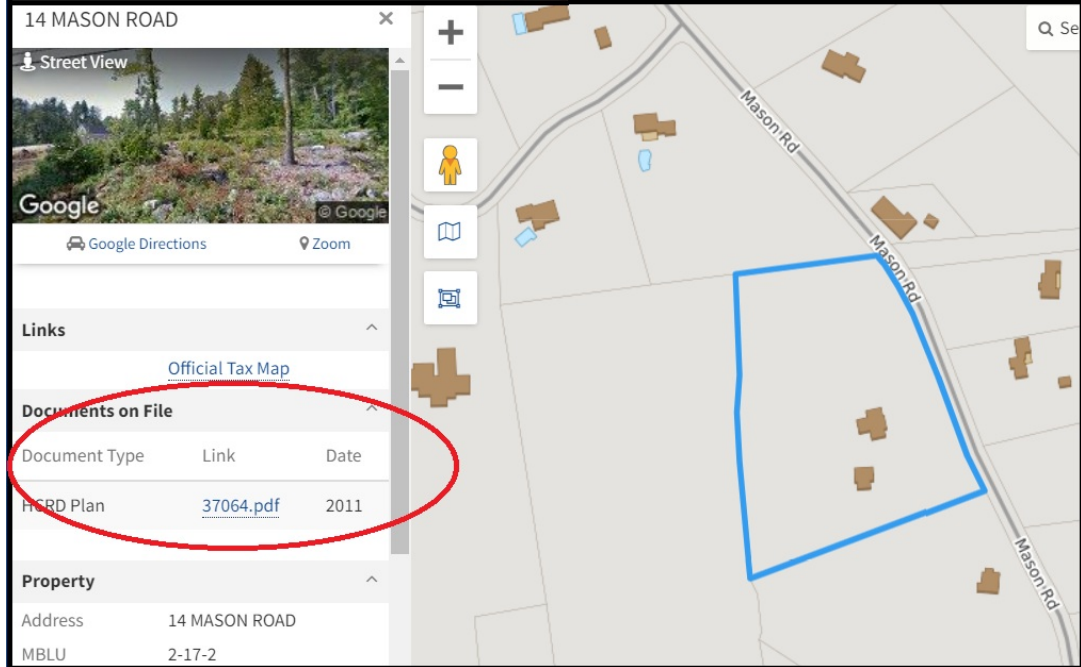


### Introducing MapGeo Documents

For well over two decades, NRPC has maintained GIS parcel data for the region. To support tax mapping, zoning analyses, and other local and regional planning activities, NRPC's parcel data must agree with the legal recording of land plats on file at the Hillsborough County Registry of Deeds (HCRD).



NRPC has digitized our collection of nearly 2000 HCRD recorded plans and have made them available in MapGeo. Now, if a selected parcel has one of these associated documents on file, a link will appear in the left-side data panel. [Go to the MapGeo Parcel Viewer.](#)

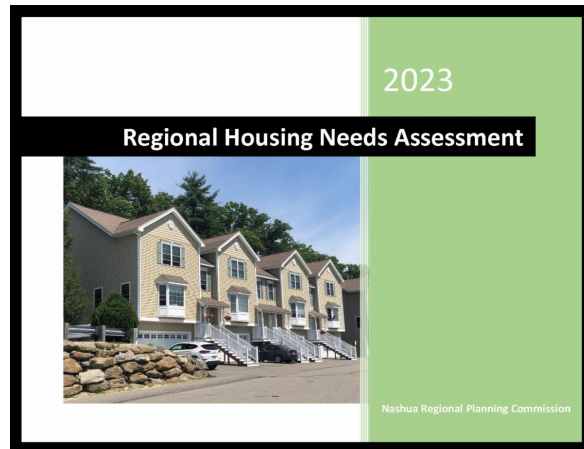


## 2023 Regional Housing Needs Assessment
